EDUCATIONAL INTERNSHIP AGREEMENT BETWEEN



Accademia Nazionale D'Arte Drammatica "Silvio D'Amico" (hereby called "Host"), with registered office in Via Bellini 16 – 00198 Roma, tax code n° 80218690586, represented by the director **Daniela Bortignoni** as legal representative, residing for the charge at the Entity's office.

AND

Guildhall School of Music & Drama (Hereby called "Promoter")
With registered office in Silk Street, Barbican, London, EC"Y 8DT
represented by Eliot Shrimpton
Born in Sidcup on 3rd December 1975, as pro tempore legal representative, residing for the charge at the Entity's office.

GRANTED

That the Parties concerned, as above represented and domiciled, agree on the necessity to develop appropriate links between the world of education and the world of work, in order to enhance the quality of educational processes and to improve the circulation of the enterprise culture;

That educational and orientation internships are presently regulated by art.18 Law 24

June 1997 n. 196 and by the Ministry of Labor and Social Policy, in concert with the

Ministry of Public Education and of University and Research issued by the Decree 25 March
1998, n.142;

The parties hereto stipulated and agreed as follows:

Article 1

The above-mentioned premises are integral and essential part of the present Agreement.

Article 2.



With the present Agreement, the Parties identify conditions and modalities about how to complete educational internships by the Host, by students attending the Accademia Nazionale D'Arte Drammatica "Silvio d'Amico".

Article 3.

The relationship between the Host and the interns is not to be considered a business relationship, in accordance with the art. 18, comma L, letter D, of the Law 196 of 1997. The internship's nature is merely educational and the intern has to pursue only purposes of didactics and knowledge of the productive work. Therefore, the practical aspects of the internships, which takes place with the operative assistance of a tutor named by the Host as in Art.8 of the present Agreement, cannot imply any taking on responsibility by the intern concerning the activities he's involved in.

Article 4.

The Promoter fully commits itself to diffuse the open internship positions offered by the Host and to individuate the fittest candidates amongst the applicant by means of a selection operated by a commission established to this end by a directorial decree.

The Host, in accord to the legislative decree 196/2003 and its subsequent modifications or integrations, commits itself not to diffuse by any means the received data and to only use them to the purpose of the present Agreement.

Article 5

In full compliance and recall to the present Agreement, which constitutes statutory compliance, for each and every internship resulting from it, the Host and the Promoter arrange an Educational Project in which the modalities of the internship are explained. This Project will be handed to the Host contextually to the individuation of the candidate.

The Promoter will send the Host the curricula of the students, selected by a commission established to this end by a directorial decree, so that the Host may choose the candidate that will be offered the internship. The Parties will evaluate a draft of the Educational Project

which will be indicated contextually to the individuation of the candidate and which will be

Article 6.

The Host will provide to insure the intern when inside the building of the Accademia and inside the building of all the other headquarters of the Accademia, against reimbursement of euro 200,00 to cover the expenses for this insurance, by bank transfer to: Accademia Nazionale d'Arte Drammatica "Silvio d'Amico"

Article 7.

The Host guarantees to:

- Nominate a enterprise (or entity or institution) tutor who will follow the course of the internship with all the appropriate care;
- Notify the Promoter of any event concerning the intern (absences, harmful behaviors to the rights and interests of the enterprise or entity or institution).

Article 8.

The Host guarantees to provide the intern with adequate information to prevent workplace accidents. All notions useful to this effect are to be considered by the intern as a necessary subject.

The Host also engages in guaranteeing the intern with the safety and hygienic conditions in force to the current regulation and in discharging the Promoter of the expenses for verifications.

Article 9.

The Promoter and the Host engage in jointly issuing a statement of the proficiency reached by the intern and the end of the internship.

Article 10.



GO NOTES



The internship will not involve any financial charge for the Host, nor any of other nature than those issued in the present Agreement.

Both the intern and the Host without notice may interrupt the internship at any point.

Article 11.

The present Agreement is valid until 18 months after its pledge.

Article 12.

The Parties agree on solving any controversy that may take place from this Agreement in a friendly way; in case this is not possible, the Forum of Rome is to be considered competent.

Article 13.

In accordance with what provided by articles 1341 and 1342 C.C. the Parties both declare to have carefully read all the clauses and provisions above transcribed which are to be considered explicitly and unconditionally approved.
