Art. 1. THE PARTIES INVOLVED IN THIS AGREEMENT ARE:

BABEȘ-BOLYAI UNIVERSITY, Cluj-Napoca, M. Kogălniceanu street, nr. 1, phone number: +40 264405300, fax: 0264/590592, CIF 21524920, account opened at Banca Comercială Română, IBAN RO16RNCB0106026604700008, represented by Dr. Daniel David Univ. Professor as Rector, and Dr. Liviu Malița Univ. Professor as Dean of Faculty of Theatre and Film, with sufficient powers for the act, hereinafter referred to as the **ORGANIZER**. and

ACCADEMIA NAZIONALE D'ARTE DRAMMATICA "SILVIO D'AMICO", registered office at Vincenzo Bellini, no.16 - 00198 Rome, CIF 80218690586, represented by as, hereinafter referred to as **PARTNER**.

Art. 2. PURPOSE OF THE AGREEMENT

The subject of this agreement is the partnership organisation of educational and artistic events.

Art. 3. DURATION OF THE AGREEMENT

This Agreement is valid from June 8, 2023, until June 11, 2023.

Art. 4. RIGHTS AND OBLIGATIONS

a) Obligations of the ORGANIZER:

- 1) to participate in the PILADE performance project;
- 2) to provide accommodation for the 12 students and 1 teacher of the Silvio d'Amico National Academy of Dramatic Arts from 8 to 11 June. The students will be accommodated in the BBU Camin 14, and the Professor will be accommodated in a hotel in the city centre of Cluj-

Napoca. The total estimated cost for the accommodation of the whole group (students + professor) is approximately 2200 lei.

- 3) to provide technical support for the smooth running of the performance;
- 4) to mention in the promotional activities of Pilade show (on the website, on social networks, in press materials) the quality of partner and producer of the National Academy of Dramatic Arts Silvio d'Amico;
- 5) to avoid any risk-generating situation that may negatively affect the image of the Silvio d'Amico National Academy of Dramatic Arts.

b) Obligations of the PARTNER:

- 1) to provide the necessary information materials to promote the event: presentation of the show, photos, university logo;
- 2) to inform the Faculty of Theatre and Film of any changes to the programme;
- 3) to avoid any risk-generating situation that may negatively affect the image of the Faculty of Theatre and Film, Cluj Napoca;
- 4) to promote the show and the event Galactoria 2023 by the means at its disposal.

Art. 5. TERMINATION OF THE PARTNERSHIP AGREEMENT

This Agreement shall terminate in the following cases:

- (a) by giving 30 days written notice prior to the date of termination of the Agreement;
- (b) upon expiry of the term for which it was concluded;
- (c) if the Parties fail to comply with their essential obligations under this Agreement, after prior notification to that effect.

Art. 6. OTHER CLAUSES

The partners may amend or supplement the scope of this Agreement, in full agreement, with any other projects they consider essential to achieve the common purpose set out in the preamble.

Force majeure shall exempt the parties from liability in the event of improper or delayed performance of their obligations under this Agreement.

Force majeure means an unforeseeable and insurmountable event beyond the control of the parties which occurs after the conclusion of the contract and which prevents the parties from performing their obligations.

The parties declare that they are aware of the legal provisions on the protection of personal data. Any personal data known on the occasion of the conclusion and implementation of this Agreement shall be used only for the purpose resulting from the Agreement and may be disclosed to other authorised persons only within the limits of the legal provisions on reporting obligations.

Art. 7. SETTLEMENT OF DISPUTES

Any dispute which may arise out of the performance of this Agreement shall be settled amicably, and only in the event that this amicable settlement cannot be achieved, the parties may apply to the courts having jurisdiction in the material and territorial sense.
