*Signed in St Petersburg, Russia, on April 15th, 2011 during the 14th Europe Theatre Prize.*

Ten European Theatre Academies and Schools have agreed to form a union. The union is entitled:

EUROPE: UNION OF THEATRE ACADEMIES AND SCHOOLS

(E:UTAS)

### *Vision*

E:UTAS aims to participate in the process of creating a united Europe, celebrating the range and diversity of cultural and creative expression. Further, it aspires to redefine the role of the theatre institutions and to be a driver of the development of 21<sup>st</sup> century practitioners.

Our wish is to bridge the gap between the education of artists who create and perform theatre, and their artistic careers. We shall do this by offering the space and support for students to take responsibility for their own generation's theatre by the creation of student-led work.

Our academies and schools were invited to form this union by the General Secretary of Europe Theatre Prize, Alessandro Martinez. We appreciate this opportunity given to us by him and his committee.

We support the Europe Theatre Prize and as E:UTAS we commit to creating and managing "On the Way" as part of the annual Union Theatre Prize event.

We believe that from this initiative future winners of the Europe Theatre Prize and the Europe Prize New Theatrical Realities will emerge.

We sign this Memorandum of Agreement in the spirit of trans-European partnership.
